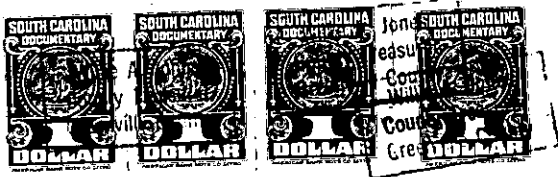
KNOW ALL MEN BY THESE PRESENTS, that C. E. LLOYD
