Paul M. O'Neal, Jr. and Judy S. O'Neal, their heirs and assigns forever:

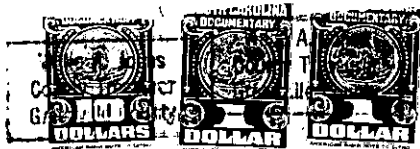

Beginning at an iron pin on the southwestern side of Lancaster Lane at the joint front corner of Lots Nos. 284 and 285 and running thence along the joint line of said lots S. 38-28 W. 128.4 feet to an iron pin; thence S. 51-30 E. 103.2 feet to an iron pin; thence along the joint line of Lots Nos. 285 and 286 N. 26-35 E. 141.1 feet to an iron pin; thence along the southwestern side of Lancaster Lane N. 59-14 W. 75 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 845, at Page 270.

This conveyance is subject to such easements, restrictions and right of way as may appear of record.
