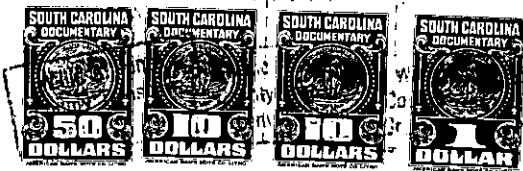
JAMES A. PATE AND MARIE R. PATE, THEIR HEIRS AND ASSIGNS, FOREVER:
