All that piece, parcel or lot of land lying, being and situate on the North side of Haven Drive about 3 miles Northwest of Greer, in Oneal Township, County and State aforesaid, and being known and designated as lot no. Nineteen (19) of the Valleyhaven property of W. Dennis Smith as shown on plat prepared by H. S. Brockman and John A. Simmons, Registered Surveyors, dated July 22, 1959 and which plat has been recorded in the R. M. C. Office for said County in Plat Book TT, page 11, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the North side of Haven Drive at the joint front corner of lots nos. 19 and 20 as shown on said plat, and running thence with the joint property line of said two lots N.1-53 W.179 feet to an Iron Pin located at the joint rear corner of lots nos. 3, 4, 19 and 20 as shown on said plat, thence with the joint property line of said lots nos. 3 and 19 N. 50-05 W.131.5 feet to an Iron Pin located on Southeast side of Haven Drive at a joint corner of lots nos. 3, 19 and 21 as shown on said plat, thence S.1-30 E.263 feet to an Iron Pin located on the North side of Haven Drive, thence with the North side of Haven Drive N.89-45 E.100 feet to the beginning point.
