All that certain piece, parcel or lot of land situate, lying and being on the Easterly side of Razor Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 as shown on plat entitled "Property of Anne L. Ferguson", prepared by J. C.
