unto Lanny W. Westmoreland, his heirs and assigns forever,

All of my one-half (1/2) undivided interest in and to all that piece, parcel or lot of land situate, lying and being on O'Neal Township, Greenville County, South Carolina, about four (4) miles northwest of Greer, South Carolina, and lying on the northern side of a county road which connects the Buncombe Road and the Old Rutherford Road, known as Copeland Road, and having, according to a plat made by Terry T. Dill, August 8, 1967, recorded in Plat Book XXX at Page 129, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Copeland Road and running thence N13-15W 610 feet more or less, to an iron pin; thence S55-49E 448.6 feet more or less, to an iron pin in the center of Copeland Road; thence with the center of Copeland Road S34-11W 413 feet more or less, to an iron pin; the point of beginning.
