KNOW ALL MEN BY THESE PRESENTS, that We, O. S. Bradshaw and Talsie C. Bradshaw

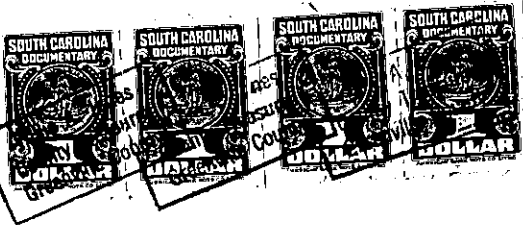
in consideration of One Thousand, Six Hundred and 00/100 (\$1,600.00) Dollars,
