the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

ALL that piece, parcel or lot of land with improvements lying on the Southern side of Prentiss Avenue and in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 10, Block L, on a Plat of the Property of O. P. Mills, made by H. O. Jones, Engineer, dated May, 1914, and recorded in the RMC Office for Greenville County, S. C., in Plat Book C, page 176, reference to which plat is hereby craved for the metes and bounds thereof.

The above property is the same acquired by the Grantors in Deed Book 865, page, 635, and is hereby conveyed subject to rights of way, easements, conditions, public roads and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.

As a part of the consideration for this conveyance, the Grantee herein assumes and agrees to pay in full the balance remaining due on a mortgage to Cameron-Brown Company dated April 11, 1969, and recorded the same date in the RMC Office for Greenville County, S. C., in Mortgage Book 1122, page 411, in the original sum of \$17,500.00, which has a present balance due in the approximate sum of \$17,433.55.

As a part of the consideration for this deed the Grantors assign and transfer to the Grantee all their right, title and interest in and to any escrow deposits maintained by the above named mortgagee in connection with the mortgage loan covering the above described property.

The Grantee agrees to pay Greenville County and City of Greenville property taxes for the tax year 1969 and subsequent years.
