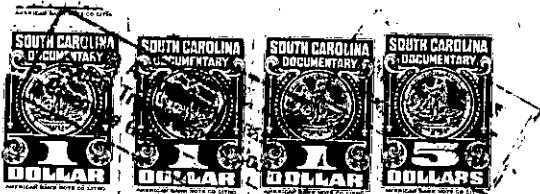
KNOW ALL MEN BY THESE PRESENTS, that Colonial Company, Inc.
