All that certain piece, parcel or lot of land, situate, lying and being on the eastern side of Ashford Avenue, being shown and designated as Lot 93 on a plat of Property of Ralph H. Witt, revision of Lots 92 and 93, Vista Hills, made by Dalton & Neves, September, 1951 and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book AA, Page 151, and having, according to said plat, the following metes and bounds, to wit:
