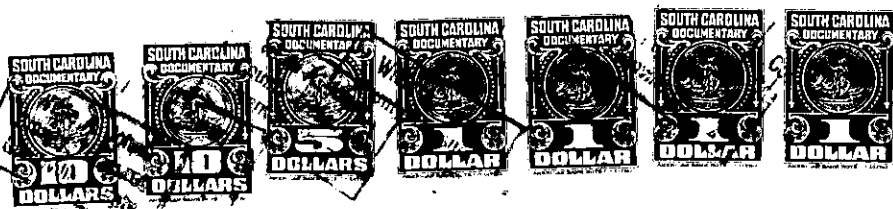
CLAUDE VESTAL JESTER AND VIRGIE MAE M. JESTER, THEIR HEIRS AND ASSIGNS, FOREVER:
