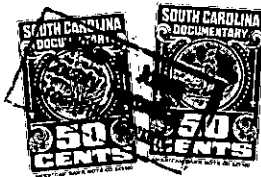
in consideration of Four Hundred Fifty & no/100 - - - - - Dollars,
