All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Pine Ridge Drive near the City of Greenville, being shown as Lot 13, Sec. 2 of Fresh Meadow Farms, made by Madison H. Woodward, Engineer, May 21, 1945, and having according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the southwestern side of Pine Ridge Drive, joint front corner of Lots 12 and 13 and running thence along the line of Lot 12 S 45-30 W 200 feet to an iron pin; thence S 44-30 E 90 feet to an iron pin; thence with the line of Lot 14 N. 45-30 E 200 feet to an iron pin on the southwestern side of Pine Ridge Drive; thence along Pine Ridge Drive N 44-30 W 90 feet to the beginning corner.
