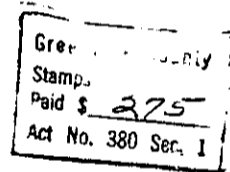
in consideration of Twenty-five Hundred (\$2500.00) Dollars,

All that piece, parcel or lot of land in Austin Township, Greenville County, state of South Carolina, in the town of Mauldin, S. C., being known and designated as Lot No. 20 on Map No. 2 of Sunset Heights made by C. O. Riddle, September 17, 1953 and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Sunset Drive, the joint corner of Lots Nos. 19 & 20; thence with the joint line of said lots N. 27-25 W. 200 feet to an iron pin; thence N. 62-35 E. 100 feet to an iron pin corner of Lot No. 21; thence with the line of said lot S. 27-25 E. 200 feet to an iron pin on the north side of Sunset Drive; thence with the north side of said Drive S. 62-35 W. 100 feet to the beginning corner.
