the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Rebecca H. Smith, her heirs and assigns forever;

ALL that certain piece, parcel or lot of land situate on the northwestern side of Arbutus Trail, in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 39 on plat of Elletson Acres, recorded in Plat Book EE at Page 161, and having according to said plat the following metes and bounds, to-wit:
