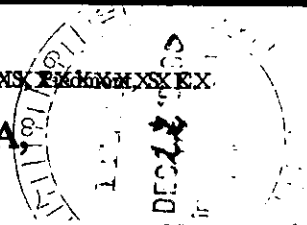

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Eula D. Morrow, her heirs and assigns forever,

all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying just north from the City of Greer, near South Carolina State Highway No. 14 and about 150 feet west therefrom, and also lying on the east side of a new street, and bounded on the South by another new street, and being Lots Nos. 18 and 19 on plat of property made for Margaret M. Green by H. L. Dunahoo, Surveyor, dated June 2, 1947, which plat is recorded in the Office of RMC for Greenville County in Plat Book B, Page 108, said lots having the following courses and distances, to-wit:

BEGINNING at a stake at the intersection of said two new streets and runs thence along the eastern edge of the new street N 32.15 W 150 feet to a stake, corner of Lot No. 17; thence N. 84.35 E. 130 feet to a stake, joint corner of Lots 3, 4, 17 and 19; thence S 23.45 E 150 feet to a stake on the north side of new street; thence with the northern edge of this street S 84.35 W 110 feet to the beginning corner.

The grantors and grantees are all the heirs at law of W. O. Morrow who died May 27, 1952 Intestate in Greenville County.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
