(6) All that certain piece, parcel and lot of land lying and being in Gantt Township, Greenville County South Carolina, near the City of Greenville, lying and being in that certain subdivision known as "Belle Meade" and being shown on a plat made for Derby Heights Inc. March 11, 1966 by Webb Surveying and Mapping Co. described as follows:

The northern portion of Lot No. 406 having a frontage of 50 feet on Pine Creek Court and going back a depth of 194 feet, reserved for a road; plus a rear portion of Lot No. 407 and a portion of the rear of Lot No. 406, fronting 94 feet on an uncut road, having a depth of 110 feet and 94 feet wide at the rear. - 159 - WC 2,3 - 1 - 67, 68

(9) All that piece, parcel or tract of land, situate, lying and being in Gantt Township, Greenville County, South Carolina, lying on the South Side of S. C. Highway 291, BY-PASS (Interstate Highway I-85) and on the Ease side of East Dorchester Boulevard containing 2.4 acres, more or less, according to plat of the property of Derby Heights Inc. made by Dalton & Neves, Engineers, dated November 1958 and having, according to said plat, the following description:

Beginning at an iron pin at the Southeastern intersection of East Dorchester Boulevard and S. C. Highway 291, By-Pass (Interstate Highway I-85) and running thence along and with the southern edge of the right of way of the said highway, N. 82-12 E. 683.4 feet to an iron pin, corner of property now or formerly of J. B. Orders; thence along and with the said Orders property S. 17-35 W. 190.6 feet to an iron pin near Brushy Creek; thence N. 88-21 W. 127.2 feet crossing Brushy Creek to an iron pin in the old run of the branch; thence with the old run of the branch, S. 77-43 W. 440 feet to an iron pin in the East side of East Dorchester Boulevard; thence along the East side of East Dorchester Boulevard, N. 19-0 W. 190.2 feet to the point of beginning. - 159 - 368 - 1 - 14
