in consideration of Seven thousand eight hundred and 00/100---(\$7,800.00)----- Dollars,

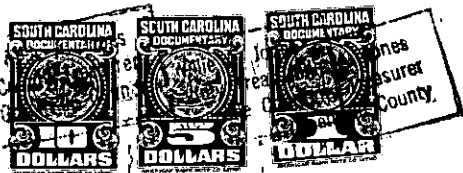
