and assumption of mortgage described below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto R. KENNETH COBB, his heirs and assigns;

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 36 of a Portion of Heathwilde as shown on plat thereof prepared by Campbell & Clarkson, Surveyors, May 23, 1968, and recorded in the RMC Office for Greenville County in Plat Book WWW at Page 18 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Canterbury Road, joint front corner of Lots 35 and 36 and running thence along the southern side of Canterbury Road, S. 76-58 W. 48.4 feet to an iron pin; thence continuing along the southern side of said road, S. 80-36 W. 101.5 feet to an iron pin; thence continuing along the southern side of said road, S. 83-40 W. 100 feet to an iron pin at the corner of Lot 37; thence along the line of that lot, S. 15-19 E. 207.5 feet to an iron pin, joint corner of Lots 34, 36, 37 and 38; thence along a rear line of Lot 34, N. 60-06 E. 172.45 feet to an iron pin at the joint rear corner of Lots 34, 35 and 36; thence along a line of Lot 35, N. 15-32 E. 158.3 feet to the beginning corner.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to James A. Harris assigned to Citizens Builders Mart, Inc. and Carolina Insulating Co., Inc., on which there is a balance due of \$ 17,000.00 ; said mortgage being recorded in Mortgages Volume 1139, Page 529.

This is the same property conveyed to the grantor by deed recorded in the RMC Office for Greenville County, S.C., in Deed Volume 877 at Page 523.

Grantee also assumes mortgage to Carolina Insulating Co., Inc. in the amount of \$2800.00, recorded in Mortgages Vol. 1139, page 535.
