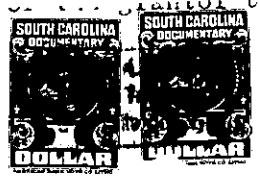

KNOW ALL MEN BY THESE PRESENTS, that Michael Ansel Brown,

in consideration of Six Hundred and No/100----- (\$600.00)----- Dollars,
 and assumption of mortgage referred to below,
 the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
 unto Adam Fisher, Jr., his heirs and assigns forever,

All that certain piece, parcel or lot of land, situate, lying and being on
 the west side of Marlboro Drive in the County of Greenville, State of South
 Carolina, being shown and designated as Lot 288 on a plat of Section 3, Belle
 Meade, recorded in the RMC Office for Greenville County, South Carolina, in
 Plat Book "GG", Page 187, and having, according to said plat, the following
 metes and bounds, to-wit:

Beginning at a point on the west side of Marlboro Drive at the joint front cor-
 ner of Lots 288 and 289 and running thence along the common line of said Lots,
 N. 87-04 W. 135.1 feet to a point, joint rear corner of Lots 288, 289 and 272;
 thence along the line of Lot 272, N. 51-30 W. 53.9 feet to a point; thence
 along the line of Lot 286, N. 34-20 E. 31.7 feet to a point, joint corner of

 assumes the obligations of the grantor under the terms of the instruments
 creating the loan to indemnify the Veterans Administration to the extent of any
 claim payment arising from the guaranty or insurance of the indebtedness above
 mentioned.
