the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto R. KENNETH COBB, his heirs and assigns;

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 34 of a Portion of Heathwilde as shown on plat thereof prepared by Campbell & Clarkson, Surveyors, May 23, 1968, and recorded in the RMC Office for Greenville County in Plat Book WWW at Page 18 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Canterbury Road, joint front corner of Lots 33 and 34 and running thence along the western side of Canterbury Road, N. 17-30 E. 200 feet to an iron pin at a corner of Lot 35; thence along the line of that lot, N. 72-30 W. 172 feet to an iron pin at the joint corner of Lots 34, 35, and 36; thence along the rear line of Lot 36, S. 60-06 W. 172.45 feet to an iron pin at the corner of Lots 34, 36, 37 and 38; thence along a rear line of Lot 38, S. 4-30 E. 80 feet to an iron pin at a rear corner of Lot 33; thence along the line of that lot, S. 72-30 E. 259.8 feet to the beginning corner.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to James A. Harris assigned to Citizens Builders Mart, Inc. and Carolina Insulating Co., Inc., on which there is a balance due of \$17,000.00; said mortgage being recorded in Mortgages Volume 1139, Page 531.

This is the same property conveyed to the grantor by deed recorded in the RMC Office for Greenville County S.C. in Deed Volume 877 at Page 525.

Grantee also assumes mortgage to Carolina Insulating CO., Inc. in the amount of \$3200.00, recorded in Mortgages Volume 1139, Page 531.
