in consideration of -----Nine Thousand Eight Hundred and No/100 (\$9,800.00)----- Dollars,

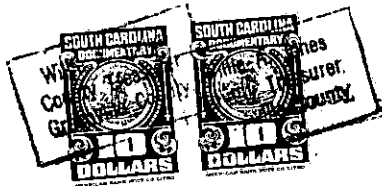
