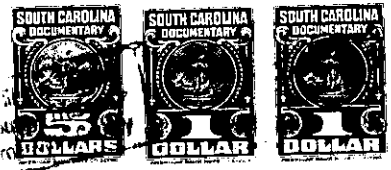
in consideration of Three Thousand, One Hundred Sixteen and 05/100 (\$3,116.05) ----- Dollars,
