unto

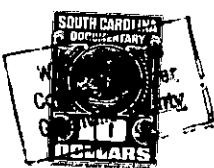
Lewis C. Terry, his Heirs and Assigns forever:

ALL that certain tract of land, with the improvements thereon, situated in Fairview Township, County of Greenville, State of South Carolina, containing 65.75 acres in accordance with plat made by James P. Willis, dated September 27, 1921 for J. Russell Terry, Sr., and being more fully described in accordance with said plat, to-wit:

BEGINNING at a stone in the road, joint property corner of Grantor's property and that of Lewis C. Terry, and being the northwestern corner of Lewis C. Terry property and running thence due east 11.13 chains to a stone; thence N. 59½ W. 29.06 chains to a stone; thence S. 25 W. 9.60 chains more or less to a point; thence S. 64 E. 3.85 chains to a stone; thence S. 37 W. 8.50 chains to a stone; thence in a southeast direction 8 chains more or less to a stone; thence N. 74½ E. 10.16 Chains to a point; thence S. 69½ E. 10.38 chains to a point in center of road above referred to; thence along the center of said road N. 8½ E. 9.90 chains to point; thence N. 18½ W. 9.63 chains to a point; thence N. 21½ E. 4.50 chains to a point, being the point of beginning.
