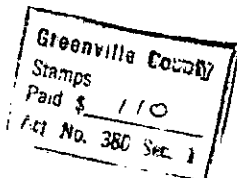
KNOW ALL MEN BY THESE PRESENTS, that I, Josephine C. Hammond
