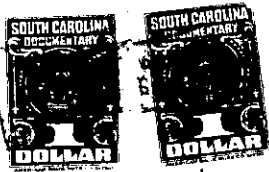
KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County,

unto Richard P. Green, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, as is more fully shown on a plat of property of J. H. Mauldin dated September, 1962 and prepared by C. C. Jones, Civil Engineer, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corner of Lots 1 and 2 of Mauldin Meadows Subdivision as is more fully shown in a plat recorded in Plat Book EE, at Page 151, and running thence S. 63-45 E. 204 feet, more or less, to a point; and running thence S. 3-05 E. 92.7 feet to an iron pin; running thence S. 38-20 W. 101.7 feet to an iron pin; running thence N. 73-33 W. 170 feet to an iron pin in the center of North Parker Road; and running thence along a line with North Parker Road, N. 30-16 W. 237.6 feet to an iron pin at the front corner of Lot No. 1, Mauldin Meadows Subdivision; and running thence along the curvature of the southern edge of North Parker Road, S. 44-18 E. 158.2 feet to an iron pin; running thence N. 20-15 E. 37 feet to an iron pin at the corner of Lot No. 1, Mauldin Meadows Subdivision; running thence along the rear line of Lot No. 1, Mauldin Meadows Subdivision, N. 22-40 E. 80.2 feet to the point of beginning.
