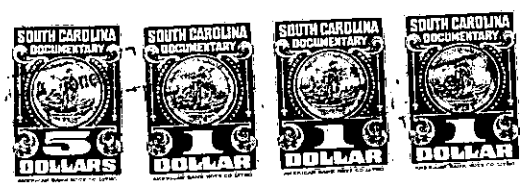
KNOW ALL MEN BY THESE PRESENTS, that C. S. Willingham -----
