PIEDMONT CHEMICAL INDUSTRIES OF SOUTH CAROLINA, INC., Carolina , corporation, Grantor, for and in consideration of the sum of ONE DOLLAR (\$1) to it in hand paid by the Grantee hereinafter named, receipt whereof is hereby acknowledged, has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto SOUTHERN RAILWAY COMPANY, a Virginia corporation, Grantee, its successors and assigns,

AN EASEMENT OR RIGHT OF WAY, over and upon that certain strip, piece or parcel of land of Grantor, situate, lying and being at GREENVILLE (Donaldson Center), in Greenville County, South Carolina, for railroad purposes; said easement or right of way being more particularly described as follows:

BEGINNING at a point on the easterly boundary of the right of way of Grantee for an existing industrial lead track of Grantee 10 feet, measured at right angles, east of the located center line of a proposed industrial track to serve F. W.
