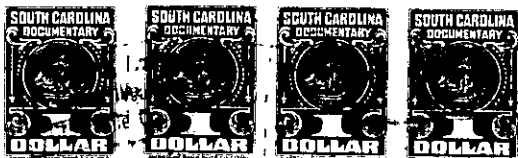
J. ODELL SHAVER, His Heirs and Assigns:

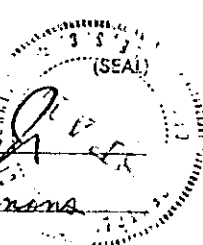
