- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows:
 Beginning at iron pin on the the eastern side of Hemlock Street, at the joint front corner of Lots #5 & 6, and running thence with the line of Lot #5N. 53-15E. 125 feet to point in line of Lot #7; thence with the line of Lot #7, S. 41-45E. 100 feet to an iron pin on the northern side of Thomas Drive; thence with the northern side of Thomas Drive, S. 48-15 W. 95.9 feet; thence with the curve of the intersection of Thomas Drive and Hemlock Street in a northwesterly Direction 25 feet to pin on Hemlock Street; thence continuing with the eastern side of Hemlock Street, N. 45-15 W. 85 feet to the point of beginning. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
