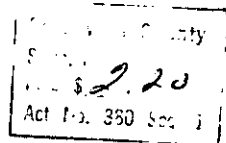
in consideration of **ONE THOUSAND NINE HUNDRED FIFTY AND NO/100 (\$1,950.00)** Dollars,
