KNOW ALL MEN BY THESE PRESENTS, that OAK, INC.

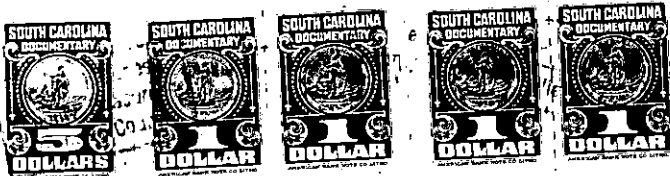
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Four Thousand Two Hundred Seven & 50/100 (\$4,207.50)-----Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

O. H. Ogle, his heirs and assigns forever:

ALL that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Holly Road near the City of Greenville, being shown as Lot # 2 on plat of EDWARDS FOREST HEIGHTS recorded in Plat Book 00 at page 89, and more fully described as follows:

BEGINNING at an iron pin on the northern side of Holly Road at the joint front corner of Lots # 1 and # 2 and running thence with the joint line of said lots North 38-07 West 175 feet; thence North 51-53 East 110 feet to the joint rear corner of lots 2 and 3; thence South 38-07 East 175 feet with the joint front corner of said lots on Holly Road; thence with Holly Road South 51-53 West 110 feet to the beginning corner.
