in consideration of Eighteen Thousand and no/100----(\$18,000.00)----- Dollars,

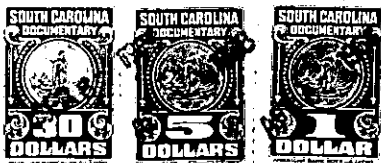
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Beuna G. Moore, their William H. Moore, and heirs and assigns forever,

All that certain piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, containing 2.48 acres, situate at the Southeast corner of the intersection of View Mont Drive and Parker Road and having according to plat of the property of Catherine R. Burns made by J. C. Hill on July 9, 1952, the following metes and bounds:

BEGINNING at an iron pin at the intersection of View Mont Drive and Parker Road and running thence with the center of Parker Road, S. 35=30 E. 184.1 feet to a pin; thence N. 71-53 W. 516.9 feet to a pin; thence N. 20-10 W. 241.4 feet to a pin in the center of View Mont Drive; thence with the center of View Mont Drive, the following courses and distances: S. 50 W. 45 feet; S. 61-45 W. 104 feet; S. 75-05 W. 169.5 feet; S. 65 W. 250.1 feet to a pin in the center of the intersection of View Mont Drive and Parker Road, the point of beginning.
