All that certain piece, parcel or lot of land, situate, lying and being on the north side of Hawthorne Drive in the County of Greenville, State of South Carolina, being shown and designated as Lot 66 on a plat of Greenbrier, made by Charles F. Webb, September, 1957, recorded in the RMC Office for Greenville County in Plat Book QQ, Page 65, and having according to said plat the following metes and bounds, to-wit:
