KNOW ALL MEN BY THESE PRESENTS, that C. F. Weatherford and Ellen Holder Weatherford -----

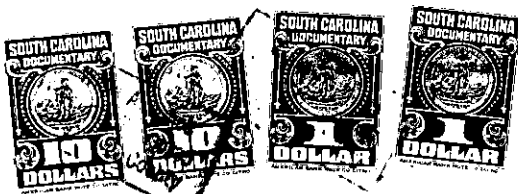
in consideration of Eleven Thousand and No/100 (\$11,000.00) ----- Dollars,
