ALL that certain, piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township near the corporate lines of the City of Greenville in Tax District of 235 being known and designated as Lot 216 of a subdivision of the Village of Mills Mill as shown on a plat thereof made by Piedmont Engineering Services of Greenville, South Carolina, in June, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Pages 60 and 61 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Mission Street at the joint front corner of Lots Nos. 217 and 216 and running thence S. 53-43 W. 82 feet to an iron pin at the joint rear corner of Lots 216 and 217; thence with the joint line of Lots Nos. 215 and 216 S. 34-46 E. 71.5 feet to an iron pin on the northern side of Park Street, the joint front corner of Lots Nos. 215 and 216; thence with the western side of Park Street, N. 58-14 E. 84 feet to an iron pin at the intersection of Park Street and Mission Street; thence with the western side of Mission Street, N. 36-17 W. 78 feet to the point of beginning.
