the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

J. L. Tomlinson and Billie T. Rutherford, their heirs and assigns forever:  
All my right, title and interest, being an undivided one-ninth interest, in and to the following described real estate:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, Greenville Township, in the First Ward of the City of Greenville, and on the northeast side of Pinckney Street:

BEGINNING at the corner of Lot No. 17, now or formerly owned by Paul Houston, and running thence N. 39-1/2 E. with said Houston's line, 296 feet to a stake at Carlisle's line; thence N. 33-1/2 W. with Carlisle's line, 22-1/2 feet to a stake at Min Powell's line; thence S. 55-1/2 W. with said Powell's line, 153 feet to a stone, corner of said Powell's lot and Lot No. 21; thence S. 39-1/2 with the line of Lot No. 21, 147 feet to Pinckney Street; thence S. 50-1/2 E. with said Street, 68 feet to the point of beginning, being designated as Lot No. 19 in the division of the home place of W. P. McBee, deceased, as shown by plat made May 16, 1902 by J. N. Southern, D. S., in Plat Book A, at Page 83 in the R. M. C. Office for Greenville County.

The above described property is the same conveyed to Mary Parks Thompson and Bobbie Tomlinson Parks by Anna W. Brown, et al. by deed dated September 12, 1950 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 419 at Page 411. By deed dated April 10, 1961, recorded in said R. M. C. Office in Deed Vol. 671 at Page 439, the said Mary Parks Thompson conveyed her undivided one-half interest to Alma A. Tomlinson. The said Alma A. Tomlinson died intestate on May 9, 1970, leaving as her heirs at law and distributees her husband, J. L. Tomlinson, and her children, Bobbie T. Parks, Billie T. Rutherford, and Hines L. Tomlinson.
