It is agreed that in the event purchaser shall fail to make the monthly payments herein called for within then (10) days after said payments fall due or shall fail to comply with this instrument in any material particular that in such event this agreement, at the option of the seller shall terminate and any and all payments made by purchaser prior thereto shall be deemed to have been paid by purchaser to seller as rent for the use of said premises and/or liquidated dameges for breach of this contract.
