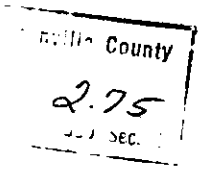
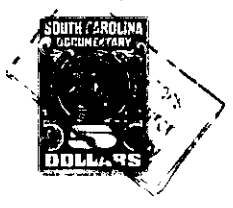
KNOW ALL MEN BY THESE PRESENTS, that Soula W. Finley
