the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto WILLIAM I. GEBERT and MAYDELLE C. GEBERT, their heirs and assigns forever:

ALL of our right, title and interest in and to:

ALL that piece, parcel or lot of land containing 1 acre, more or less, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, and having according to a plat prepared by Terry T. Dill, dated April 4, 1963, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book WW at Page 466, the following metes and bounds:

BEGINNING at an iron pin at the northwestern corner of the premises herein-described, and running thence N 88-32 E 165 feet to an iron pin; thence with the line of a 5.47 acre tract as shown on said plat S 1-02 E 265 feet to an iron pin; thence S 89-00 W 165 feet to an iron pin in the line of property now or formerly of Robert McKinney; thence with the line of the said McKinney property N 1-0 E 264 feet to the point of beginning.

The grantors previously conveyed the within described property to the grantees by deed, dated July 8, 1963, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deeds Book 729, Page 11. This deed, however, contained certain inaccuracies in the description, and the present deed is intended to correct the inaccuracies and to convey to the grantees the interest, if any, which the grantors may have in the property.

This deed does not affect the easement heretofore granted by the grantors to the grantees, recorded in said R. M. C. Office in Deed Book 751, Page 456, which continues in full force and effect for all intents and purposes.
