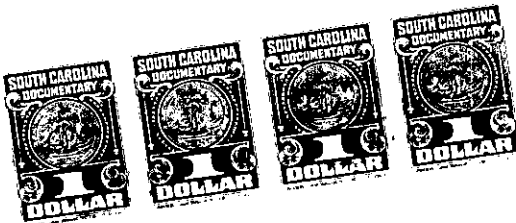
ONE THOUSAND SIX HUNDRED AND NO/100-----(\$1,600.00)----- Dollars,
