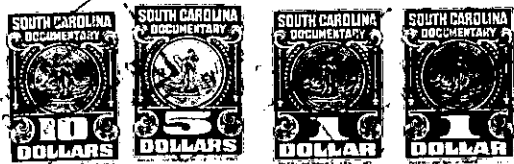
GEORGE F. STAFFORD, his heirs and assigns forever

Office for Greenville County in Plat Book 000, at page 177, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Hillsborough Drive at the corner of Lot No. 43 and running thence with the northern side of Hillsborough Drive, S. 71 E. 110 feet to an iron pin at the corner of Lot No. 45; thence with the line of Lot No. 45, N. 19 E. 180 feet to an iron pin in the line of Lot No. 26; thence with the line of Lot Nos. 26 and 27, N. 71 W. 110 feet to an iron pin at the corner of Lot No. 43; thence with the line of Lot No. 43, S. 19 W. 180 feet to an iron pin, the point of beginning.

Being the same property conveyed to the Grantors herein by Deed of W. N. Leslie, Inc., said Deed being dated July 25, 1968 and recorded in the R.M.C. Office for Greenville County in Deed Book 849, at page 167.

As part of the consideration herein, the Grantee agrees to assume that certain Mortgage given by W. N. Leslie, Inc. to Carolina Federal Savings & Loan Association of Greenville, said Mortgage being dated June 6, 1968 and recorded in the R.M.C. Office for Greenville County in Real Estate Mortgage Book 1094, at page 537. There is presently an outstanding balance due on said Mortgage of \$20,628.30.
