KNOW ALL MEN BY THESE PRESENTS, that we, William E. Wall and Sarah H. Wall

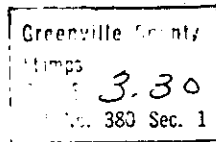
in consideration of Three Thousand and 00/100 (\$3,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Robert L. Hall and E. Ronald Higgs, their heirs and assigns, forever:

"ALL that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being known and designated as Lot No. 94, Section A of Caesars Head Company and being located on the South side of Oil Camp Drive, as shown by plat thereof recorded in Plat Book G, at page 122, in the R.M.C. Office for Greenville County and having, according to said plat, the following metes and bounds, to wit: BEGINNING at an iron pin on the South side of Oil Camp Drive at the corner of Lot 92 and running South 2-0 East 150 feet to a stake; thence around a cliff in a Northeasterly direction 182.8 feet to a point; thence North 34-0 West 150 feet to Oil Camp Drive; thence with the Southern side of Oil Camp Drive South 6-0 West 100 feet to the BEGINNING corner; being the same property conveyed to the grantors herein by deed recorded in Deed Volume 835, at page 211, in the R.M.C. Office for Greenville County."
