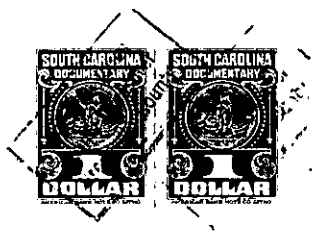
KNOW ALL MEN BY THESE PRESENTS, that I, Thomas H. Gibbs,
