ALL that certain, piece, parcel or lot of land, situate, lying and being in the Township of Chick Springs, County of Greenville, State of South Carolina, being known and designated as Lot No. 15 on a Plat prepared of the property of H. G. Stevens by W. J. Riddle, Surveyor, April, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book M, at Page 9, and having according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the east side of Paris View Drive at corner of Lot No. 16, and running thence with Paris View Drive S. 35 W. 70 feet to an iron pin at corner of Lot No. 14; thence with line of Lot No. 14. S. 51-55 E. 322.8 feet to an iron pin; thence N. 35 E. 39.2 feet to bend, and N. 18-05 E. 35.6 feet to iron pin at corner of Lot No. 16; and thence with the line of Lot No. 16, N. 51-55 W. 313.2 feet to the beginning corner.

This being the same property conveyed to me by Deed dated June 18, 1951, and recorded in the R. M. C. Office for Greenville County in Deed Book 437, at Page 85.

This property is conveyed subject to all easements, rights-of-way conditions and restrictions.

Grantor is to pay Greenville County taxes for the year 1970.
