KNOW ALL MEN BY THESE PRESENTS, that ---I, Lily McC. Loftis,---

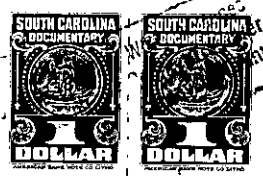
in consideration of ---Six Hundred Fifty and No/100--(\$650.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto David G. Traxler, Sr., his heirs and assigns:

ALL that piece, parcel or lot of land lying and being situate on the Southerly side of Lincoln Road, Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot #22 according to plat of property of Lily McC. Loftis revised February 23, 1961, by Terry T. Dill, R.L.S., as recorded in the R.M.C. Office for Greenville County in Plat Book GGG at Pages 456 and 457, and having, according to said plat the following metes and bounds, to-wit:
