in consideration of Two Thousand and 00/100 (\$2,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John E. Bryant, his heirs and assigns, forever:

"ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on waters of Mathers Creek, in the "Sunset Valley Sub-division", Block A, to be known and designated as Lot No. 26, on plat of John C. Smith, Surveyor, dated July, 1960, and being more fully described according to said plat as follows, to wit: BEGINNING on an iron pin at Ragsdale Drive, common corner of Lots 25 and 26 and running thence South 30-27 West 220.9 feet to a point in center of S. C. Road S-90, thence South 82-38 East 15 feet with center of road to a point; thence South 84-56 East 287.9 feet with center of road to a point where road crosses Mathers Creek; thence leaving road with center of creek North 14-28 East 124.7 feet to a point; thence with line of Lot 25 North 79-09 West 225 feet to the point of BEGINNING at Ragsdale Drive; this being a portion of the "Old Tom Clark Place" conveyed to the grantor by deed of Rachel Howard."

The grantee, his heirs and assigns, by the acceptance of this conveyance, are required to install any septic tank or other sewage disposal in accordance with the regulations of the State Board of Health, subject to inspection by local public health authorities.
