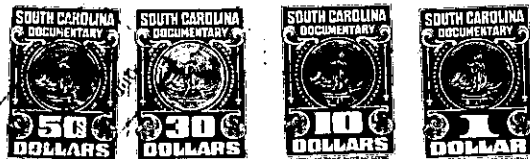
KNOW ALL MEN BY THESE PRESENTS, that Betty W. Ballenger -----
