the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROBERT F. RIDGEWAY, his heirs and assigns;

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as the major portion of Lot No. 47, Hudson Acres, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, page 39, and having according to said plat and also according to plat of property of Joe O. Charping made by C. C. Jones Engineers, March 16, 1969, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Hudson Drive, joint front corner Lots 47 and 48 and running thence N. 31-30 E. 222.35 feet to an iron pin; thence N. 34-39 W. 26.4 feet to a point; thence through Lot 47, S. 64-00 W. 320.7 feet to an iron pin on Hudson Drive; joint front corner Lots 46 and 47; thence along Hudson Drive (now Rockmont Road) S. 69-20 E. 200 feet to an iron pin, the point of beginning.
