

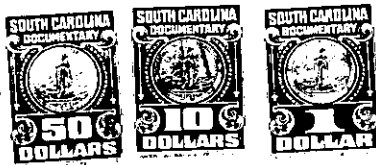
KNOW ALL MEN BY THESE PRESENTS, that DONALD E. BALTZ, INC.
